

AGREEMENT:

On the organization of joint educational activities in medical specialties of the Armenian-Russian International University "Mkhitar Gosh"

LLC Armenian-Russian International University of Mkhitar Gosh (Hereinafter referred to as the **University**), represented by executive Director: Ashokchandra Narsinhbhai Patel on the one hand has entered into this agreement as follows:

Ved Multispeciality Hospital, Ahmedabad , Gujrat, India (Hereinafter referred to as **Centre**) in the face of Director, Dr. Vaibhav patel , on the other hand, has entered into this agreement as follows:

I. SUBJECT OF THE AGREEMENT

Practical application of theoretical knowledge (Internship) in an industrial internship in the higher medical specialty of the University ("General Medicine") as the organization of the educational process by the **Centre**, according to the curricula and subject programs presented by the **University**. These include:

1. Organization of educational-professional internships.
 - a) in higher education
 - Training and production (Introduction) - 1 week.
 - Educational (Nurse Assistant) -2 weeks.
 - Assistant family doctor: Therapist, Surgeon, Gynaecologist - 3 weeks.
 - Family doctor assistant: Surgeon, Gynaecologist, Paediatrician, Ambulance Doctor Assistant - 4 weeks.
2. Define the following numbers of interns.
 - b) 200 places for "Therapeutic work" specialty.

I. SUBJECT OF THE AGREEMENT

Practical application of theoretical knowledge (Internship) in an industrial internship in the higher medical specialty of the University ("General Medicine") as the organization of the educational process by the **Centre**, according to the curricula and subject programs presented by the **University**. 1. Organization of educational-professional internships.

2. Define the following numbers of interns.

b)200 places for "Therapeutic work" specialty.

II OBLIGATIONS OF THE PARTIES

OBLIGATIONS OF UNIVERSITY

1. On the eve of each semester of the academic year (2 weeks before starting the Internship) submit to the Centre:
 - The lists of students involved in production practice by courses.
 - Software requirements and methodological instructions for practice.
2. To establish control over student attendance: throughout the entire period of production tests. Follow the students, that they;
 - Obey the rules of the Centre,
 - Conscientiously treat the presented territory and property,
And,
 - Compensate for material damage caused by students.
3. Involve conscientious and knowledgeable staff members in the training process, as lecturers and chairpersons, and conclude employment contracts with them.
4. Pay hourly wages to the employees of the Centre employed in the production practice of the University.
5. Establish the cost of the organization for each year of practical training in ——— drams / AMD.
6. Make payments to the Centre on time.
7. Timely pay salaries to the staff of the Centre, teachers involved in industrial

THE OBLIGATIONS OF THE CENTRE

1. To acquaint the students with the rules and regulations of the Centre, the rules of safety equipment.
2. To introduce to the University the doctors with skilled (Experienced, Scientific titles) (or) degrees to work at the University as lecturers of relevant medical subjects, heads of departments.
3. Create the necessary conditions for the organization of production practice.
 - 3.1 To provide cabinets and laboratories for educational programs, equipped with the necessary teaching-methodological equipment, posters, diagrams, literature, in order to organize the professional development of students and production practice.
 - 3.2 Provide students with practical laboratories with the necessary equipment and photos.
 - 3.3 Use the methodological instructions for mastering the topic for each lesson.
 - 3.4 Conduct production practice trainings in the consulting and hospital rooms of the relevant departments of the Centre, in the offices for diagnosing diseases, equipped with the necessary medical equipment.
 - 3.5. Adjust the classroom fund to students with disabilities.

3.6. Make sure that the number of students in the wards does not exceed the permissible norms.

3.7 Allow access to the services of the relevant medical departments for the following diseases:

- Internal diseases (Internal diseases, Cardiology, Pulmonologist, Nephrology, Gastroenterology, General Physiotherapy, Endocrinology, Neurology, Psychosomatics).
- Surgery (General and Operative surgery, Surgical Diseases, Intensive Care, Urology, Vascular Surgery, Neurosurgery, Traumatology and Orthopaedics).

3.8 Allow university students to work in different departments of the Centre for free or paid hours, outside of production practice classes.

4. Organize and supervise practice activities.

4.1 Have an internship plan for each type of internship.

4.2. Indicate the medical offices and departments where the internships will take place. Equip them with preventive, diagnostic, therapeutic tools and equipment

4.3. Provide internship equipment, documentation, and photos.

4.4. Form groups of internship students, attach them to lecturers.

4.5. Summarize the content of the work done with the problems solved during the internship.

4.6. Summarize the work done during the internship with the participation of students, University and Centre staff.

4.7. Ensure that the internship diaries are completed and sealed by the University.

5. Coordinate all issues and changes related to production practice with the University.

6. The teaching staff represented by the Centre is responsible for the students and their work with the Centre.

III FINAL PROVISIONS

1. This contract enters into force for 5 years from the date of signing.

2. The contract is signed in 2 copies, one of which is at the University, the other at the Centre.

3. In case of additional conditions, new contracts are concluded.

4. The contract may be terminated by agreement of the parties.

5. The contract may be terminated as a consequence:

- In case of declaring any of the parties bankrupt or in case of force majeure (Force Majeure)
- In the event of dissolution or reorganization of either party.

III FINAL PROVISIONS

1. This contract enters into force for 5 years from the date of signing.
